Briefing notes: Key factors contributing to the success of HiLite in Deeland

As we are planning to replicate our success in Veelandia by building on our success story in Deeland, it is essential that we identify the factors that contribute to our success in Deeland and then comparing this Veelandia to determine whether the same factors available there or not.

Demand Conditions

Customer in Deeland is demanding and expect high standards and value for money. 70% of them shop around for the best deal in the best location. Thus, responding to this HiLite provides best choice of locations and great value for money to its customer as highlighted by the Chief Executive Statement. They were able to provide 20% more than their nearest competitor.

HiLite continue to deliver a market leading customer experience by focusing on the quality of service to ensure they can meet the customers expectation. This is done through investment in their sites and hotel staff through refurbishments as well as upgrading the customer digital experience.

HiLite continued investment in meeting the demand of Deeland customer has ensure they are able to achieve sustainable competitive advantage given that two of Deeland's most established luxury hotel chain (Waterbay and Zeezee) has gone out of business.

Related & Supporting Industries

Developments of online hotel booking websites and price comparison sites are driving businesses to be more competitive. This is in fact working in favour of HiLite as we pride ourself in providing customer with value for money service. Thus, these developments are working in favour of HiLite that offers 'no frills' accommodation, at a reasonable price.

Online travel agent (OTA) and high street travel companies are thriving in Deeland, this will directly stimulate demand for hotel. Thus, together with Deeland's thriving tourism, opportunity for HiLite continue to grow.

Factor Conditions

Nearly half of the universities in Deeland offer travel and tourism qualification, thus we are at an advantage here as HiLite focus on our hotel staff to deliver great service. This readily skilled employees helped us to meet our goal but on a side note, we will need to focus on retention as the staff turnover in the industry is high at 60%.

Deeland government's continued investment in national infrastructure such as new airport in Boria, road and rail network development has generated more travellers that visited Deeland for leisure. This helps to ensure that demand for hotels room continue to rise which directly benefits HiLite which is well located within strategic locations in Deeland.

Firm strategy, structure and rivalry

HiLite positioned itself as a budget hotel operator, this strategy in fact fits well within Deeland landscape where customer demand value for money. Two new national branded hotel open and at the same time two long-established luxury hotel has closed is testament to the shift in demand for value for money hotel, putting us in a good position as our strategy has all the while focus on 'no frills' accommodation.

Government

Government in Deeland continued to value the hotel industry, thus investment and tax breaks for employers helps to create more competitiveness for us.

The candidate has recognised the clear link between these two pieces of information and has also considered that other organisations have not responded as successfully as HiLite. This demonstrated strong analytical skills.

HiLite's proposed acquisition of Comfi Stay Hotel chain in Veelandia

HiLite has recents announced its intention to acquire Comfi Stay Hotel chain in Veelandia and since the announcement, there has been some negative comments regarding the proposed acquisition.

The following is HiLite's responds to the recent negative accusations:

1. Employment

HiLite is committed to creating a great place to work and investing for the future. Thus, we are committed in providing staff development opportunities to help them in realising their potential especially those in Veelandia. To realise this, the management has committed \$10 million annually in skills and development programmes.

HiLite has a strong commitment to equality and diversity and we planned to uphold this in Veelandia. Comfi Hotel policy only employing male as manager will cease immediately once we have gain control, all promotion will be based on capability and contribution of the staff to the hotel performance. We have so far able to maintain our policy of equality and diversity and we do not intend to alter this for Comfi Hotel.

Long working hours and employment of minors will cease, it has never been a policy of HiLite to break any rules and regulations. We will remunerate any staff who decided to work over-time, we will ensure their salary commensurate with their work. However, the issue of Comfi Hotel staff is paid well below Deeland is a separate issue. There are many factors that contributes to this, such as cost of living and the economic development status of Deeland and Veelandia. Deeland is a developed economy thus the room rate commanded is much higher than that of Veelandia which is a developing economy, thus its not surprising there are differences in the salary between staff in the two country.

2. Environmental concern

HiLite intend to maintain its reputation of operating as a sustainable and environmentally friendly business. We have always set our target to ensure we work towards our environmental target such as reduction in emissions and recycling of waste.

Obviously Comfi Hotel's current operations and its impact on the environment will have to be reassessed. We will then set target to bring their environmental impact down to an acceptable level. We understand that a significant amount of funding is required therefore the management is committed to investment \$6 million over the next 6 years to ensure the realisation of this targets.

HiLite is committed to raise the general environmental awareness of Veelandia where currently the recycling level and emission level is low compared to others. We hope that HiLite together with the government of Veelandia can work together to raise the general awareness on the importance of environmental importance.

The management of HiLite would like to reinterate our intention of turning Comfi Hotel into one that provides a great experience for its guest and opportunities for its staff to grow.

In terms of content, the answer will reaffirm to all of its interested stakeholders the intended focus on employment opportunities, for example, including reference to HiLite's commitment to staff, the value it places on them, its commitment to diversity and equality, and its intention to commit to investment in staff development (most of which is from the CE's Report on Performance). This will be written in a way to reassure a wide range of stakeholders (including employees, shareholders, the public and customers) of HiLite's social intentions. The answer will also be further developed in the same way to address the environmental concerns of its key stakeholders (Including investment in environmental management systems to address government concerns).

Role and benefits of integrated reporting in assisting effective communication and building relationship with key stakeholders

Role of Integrated Reporting

Information comes n many form and not merely financial data, thus with IR we are able to provide a variety of information to stakeholders. This is essential as we know that different stakeholders have different information needs and making different decision based on the information. This effectively improved our communication with the stakeholders.

Benefits of Integrated Reporting

IR will help us to improve our relationship with investors as we are able to provide quality information to assist them in their decision making. By providing more relevant and broader information, investors can see and judge for themselves about out ability to create value. This will help us to maintain a long-term relationship with them.
